

The RCP LAC issue-based coalitions (IBCs) and Working Groups (WGs) are demandoriented and respond to specific needs and priorities of countries, driven by requests from respective Resident Coordinators (RCs) and United Nations Country Teams (UNCTs). Addressing critical regional development challenges, the IBCs and WGs are aligned with agreed global and regional norms and policy frameworks. IBCs and WGs operate according to an annual workplan, reporting to the RCP LAC on progress made at the end of the year in the RCP LAC system-wide results report.
